# SECOND PAN IIM WORLD MANAGEMENT CONFERENCE 2014 CALL FOR PAPERS

Participation is not limited to IIMs and papers are invited from the entire management research community in India and rest of the world.

# Theme and Sub-themes

The main theme of the conference is *Globalizing Indian Thought*. This encompasses the influencing of international perspectives through insights found in Indian realities as well as enhancing Indian thought leadership through engagement with international best practices. # **Author Guidelines**

1. Papers are to be submitted online through the <u>easychair</u> platform, the link to which is available on the conference website <u>http://wmc.iimk.ac.in</u> the submission should be in Microsoft Word format.

- 2. Papers should be written in English and should not exceed 8000 words, (excluding tables/ figures/ diagrams), with an abstract of 100–250 words and 4–7 keywords.
- 3. All papers should be submitted with 1.5 line spacing throughout with font 12point Times New Roman.
- 4. Papers should have a title page with each author's name, affiliation and contact information.
- 5. All figures, i.e., diagrams, images and photographs, and tables should be provided in the appropriate spaces. It should not be put in the end one by one. Each figure and table should have a heading, an explanatory caption if necessary, and a source or reference. Tables should be in MS Word. Figures can be submitted as TIFF/JPEG files.
- 6. Use of italics and other diacriticals should be minimized, but be used consistently, for book titles, journal names and foreign words.
- 7. Any one of the internationally accepted citation and reference guidelines should be followed consistently e.g. Harvard, Chicago, American Psychological Association. Sources for tables and figures should also be mentioned.
- 8. Copyrighted materials, including those taken from any website, should be clearly identified, and the copyright holder's explicit permission to reproduce it must be submitted separately.
- 9. No changes/ alteration will be allowed in the paper title/ abstract/ authorship once the paper has been submitted.
- 10. The paper should neither have been presented in any conference earlier nor published elsewhere.
- 11. Plagiarism in any form will result in rejection of the paper.
